- b. Company Registration Documents
- c. Developer Permit Application fee of US\$1,000 (Excl. VAT)
- d. Operator's Permit Application fee of US\$1,000 (Excl. VAT)
- e. Detailed zone layout masterplan
- f. Signed Development Agreement
- g. Signed Operator Agreement
- h. Approved Prospectus for an initial environmental impact assessment
- i. Proof of funding in the form of a bank statement/audited financials/confirmation letter from a bank.
